

AN ORDINANCE GRANTING NON EXCLUSIVE LICENSE OR FRANCHISE TO ERECT, MAINTAIN AND OPERATE TRANSMISSION AND DISTRIBUTION FACILITIES IN, UNDER, OVER, ALONG, ACROSS, AND UPON THE STREETS, LANES, ALLEYS, AVENUES, WAYS, BRIDGES, HIGHWAYS, AND OTHER PUBLIC PLACES IN THE VILLAGES OF YUKON AND WYANO, SITUATE IN THE TOWNSHIP OF SOUTH HUNTINGDON, WESTMORELAND COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF TRANSMISSION AND DISTRIBUTION BY CABLE OR TELEVISION IMPULSES AND ENERGY FOR SALE TO THE INHABITANTS OF SAID VILLAGES, AND AUTHORIZING THE PROPER OFFICERS OF THE TOWNSHIP TO EXECUTE AN AGREEMENT WITH HARRON COMMUNICATIONS CORP., FOR SUCH SERVICE AND LICENSE OR FRANCHISE.

WHEREAS, application has been made to TOWNSHIP OF SOUTH HUNTINGDON by HARRON COMMUNICATIONS CORP., a Pennsylvania corporation with its office situate in Philadelphia, Pennsylvania, for an agreement granting its permission to erect, maintain, and operate transmission and distribution facilities, in, under, over, along, across, and upon the streets, lanes, alleys, avenues, bridges, highways, and other public places in the villages of Yukon and Wyano in said Township for the interception, sale and distribution of television and other electronic signals to the inhabitants of said villages;

AND WHEREAS, the Supervisors of the Township of South Huntingdon desire to enter into the agreement heretofore described;

NOW, THEREFORE BE IT ORDAINED AND ENACTED by the Supervisors of the Township of South Huntingdon in session lawfully assembled, and it is hereby ordained and enacted that:

SECTION 1. A non exclusive franchise, or consent to erect, maintain, and operate transmission and distribution facilities in, under, over, along, across and upon public places for the purpose of transmission by cable for the interception, sale and distribution of television and other electronic signals to the inhabitants of the Villages of Yukon and Wyano situate in the Township of South Huntingdon, Westmoreland County, Pennsylvania, is hereby granted to Harron Communications Corp.

SECTION II: The proper officials are hereby authorized and directed to execute and deliver an agreement between the Supervisors of the Township of South Huntingdon and Harron Communications Corp. in the form of the agreements presented at this meeting, the terms of which are incorporated herein by reference.

SECTION III. Any ordinance or part of an ordinance conflicting with the terms and provisions of this ordinance shall be and the same in hereby repealed insofar as the same may affect this ordinance.
