WHEREAS, WESTMARC CABLE HOLDING, INC., a Delaware corpor ation, formly known as Marcus Communications, Inc. ("WestMarc"), owns and operates a cable television system in TOWNSHIP OF SOUTH HUNTIN JOON, PA., PURSUANT to a nonexclusive franchise granted by Ordiance Number 55 and Cable Communications Agreement, both dated Fabruary 24, 1983, as amended by Ordinance Number 57, dated June 27, 1985; and

WHEREAS, WestMarc has requested that, pursuant to the terms of theCable Communications Policy Act of 1984, TOWNSHIP OF SOUTH HUNTINGDON approve the transfer of its non-exclusive franchise to TCI of Greeensburg, a general partnership formed under the laws of the State of Colorado between WestMarc and TCI of Pennsylvania, Inc., a Pa. corporation; and

WHEREAS, after due consideration, analysis, and deliberation, TOWNSHIP OF SOUTH HUNTINGDON has found the financial condition and technical qualifiacations of TCI of Greensburg sufficient and resaonable to meet the future cable-related needs and interests of TOWNSHIP OF SOUTH HUNTINGDON and its residents; and

WHEREAS, EWestmarc is in substantial compliance with the material provisions of the franchise and the franchise is valid and in full force and effect as of the date of this Ordinance; and

WHEREAS, TOWNSHIP OF SOUTH HUNTIN DON desires to approve the transfer of such non-exclusive franchise.

NOW, THEREFORE, BE IT ORDAINED BY TOWNSHIP OF SOUTH HUNTIN DON that:

- 1. TOWNSHIP OF SOUTH HUNTINGDON acknowledges that WestMarc is in substantial compliance with the material provisions of the franchsie and the franchise is valid and in full force and effect as of the date of this Ordinance.
- 2. Transfer from WestMarc to TCI of Greensburg of the non-exclusive franchsie granted by Ordinance Number 55 and Cable Communications Agreement, both dated February 24, 1983, as amended by Ordinance Number 57, dated June 27, 1985, is hereby approved.
- 3. The terms and conditions of such non-exclusive franchsie shall not be amended or altered, except that (a) upon notice to the TOWNSHIP OF SOUTH HUNTINGDON, TCI of Greensburg shall be permitted to transfer such non-exclusive franchise to any of its affiliates at any time without further action on the part of TOWNSHIP OF SOUTH HUNTINGDON; and (b) all provisions of the non-exclusive franchise shall be subject to the Cable Communications Policy Act of 1984.
- 4. This approval shall be effective upon, and only effective concurrent with, the filing of an acceptance of the franchise by TCI of Greensburg within 30 days after the date of closing of the transaction transferring and assigning such cable television system from WestMarc to TCI of Greensburg, and an agreement to abide by all the provisions of the cable television franchise, subject to federal and state laws.
