ORDINANCE No.38

AN ORDINANCE AUTHORIZING THE TOWNSHIP OF SOUTH HUNTINGDON, WESTMORELAND COUNTY, PENNSYLVANIA, TO JOIN IN THE CREATION OF THE YOUGH REGIONAL PLANNING COMMISS ION: AUTHORIZING THE APPROPRIATIONOF FUNDS: APPOINTING MEMBERS THEREOF: AND AUTHORIZING THE PRESIDENT OF BOARD OF SUPERVISORS TO EXECUTE AN AGREEMENT.

WHEREAS, the County Code, Act No.130, approved the 9th day of August, 1955, as now or hereafter amended, authorizes the association together of certain municipalities in a regional planning commission; and

WHEREAS, the governing body of South Huntingdon Township, West-moreland County, Pennsylvania, recognizes the necessity for regional planning in the South Huntingdon-Smithton-Sewickley area.

THEREFORE, BE IT ORDAINED AND ENACTED BY THE TOWNSHIP OF SOUTH HUNTINGDON, in body assembled, and it is hereby ordained and enacted by the authority of the same, that the TOWNSHIP OF SOUTH HUNTINGDON:

- 1. Join and associate in the creation of a Regional Planning Commission, to be known as the Yough Regional Planning Commission in conformity with the County Code Act No.130, approved the 9th day of August, 1955, as anow or hereafter amended.
- 2. Appropriate public funds for the operation of the Yough Regional Planning Commission in an annual amount representing 45 percent of the total local costs of the Regional Planning aspects, which is the cost to the Township of South Huntingdon for expenses required to operate said Yough Regional Planning Commission of two years.
- 3.Appoint Aldo Gulion and Robert Newmyer as members to represent the Township of South Huntingdon, for a term of two years on the Yough Regional Planning Commission, and Ross Tietze as a member for a term of one year.

4. Authorize the President of Board of Supervisors of the Township of South Huntingdon to execute the future Articles of Agreement of said Commission, and direct the Township Secretary to duly attest the signature, place the corporate seal thereon, and forward a certified copy of this Ordinance to the Secretary of the Yough Regional Planning Commission.

5. All Ordinances or parts of Ordinances in conflict herewith be and the same are hereby repealed.
