ORDINANCE NO.91

AN ORDINANCE OF THE TOWNSHIP OF SOUTH HUNTINGDON, COUNTY OF WESTMORELAND, COMMONWAELTH OF PENNSYLVNAIA, AMENDING ORDINANCE NO. 90 OF THE TOWNSHIP OF SOUTH HUNTINGDON, RENAMING STATE ROAD HILL TO STATE HILL ROAD.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Board of Supervisors of the Township of South Huntingdon, Westmoreland County, Pennsylvania, as follows:

SECTION 1. Ordinance No. 90 of the Township of South Huntingdon is hereby amended to read as follows:

"SECTION 1. In order to comply with the Westmoreland County Street Naming and Addressing Guidelines, the name of the following streets and roads in the Township of South Huntingdon are hereby changed to and shall hereafter be known as follows:"

"k. That portion of street named and identified as State Hill Road (Township Road No. 377), pursuant to Ordinance No. 90, is hereby renamed and identified as State Hill Road."

"SECTION I. VEHICLE WEIGHT LIMITS ESTABLISHED ON CERTAIN HIGHWAYS, STREETS AND BRIDGES

1. On the following highways, streets and bridges or parts thereof, and by the authority granted by Section 4902 of the Motor Vehicle Code of the Commonwealth of Pennsylvania, it shall be unlawful for any person or persons to drive, operate, park, locate, situate or maintain any vehicle or combination having a gross weight in excess of the maximum prescribed below for that highway, street, bridge or part thereof, on, over, or upon such highway, street or bridge, as the case may be:"

State Hill Road Twp. Road No. 377	From S.R. 0981 to Twp. Road No. 317 (Mt. Etna Road)	10 Tons
Mt. Etna Road Twp. Road No. 317	From Twp. Road No. 377 (State Hill Road) to SR 3035	10 Tons

SECTION II: All other provisions of Ordinance No. 90 of the Township of South Huntingdon, which are not specifically amended and supplemented by this Ordinance, remain in full force and effect.

SECTION III: The provisions of this Ordinance, so far as they are the same as those of ordinances and/or parts of Ordinances in force immediately prior to the enactment of this Ordinance, are intended as a continuation of such ordinances and not as new enactments. The provisions of this Ordinance shall not affect any act done or liability incurred, nor shall they affect any suit or prosecution instituted, pending or concluded, or to be instituted to enforce any right, rule, regulation, provision, penalty or to punish any offense under the authority of any such prior ordinances.

SECTION IV: <u>Severability</u>. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionally, illegally or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses or section or part of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of the Township of South Huntingdon that this Ordinance

would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof had not been included herein.

SECTION VII: <u>General Repealer.</u> Any Ordinance or parts of Ordinances in conflict with this Ordinance are hereby specifically repealed.

SECTION VIII: Effective Date. THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY.
